Membership Agreement

In consideration of payment by Member of initiation fee and all annual dues in accordance
with the By-Laws (Article X), the Club hereby grants Member all the rights and privileges of
membership in the Club, subject to all of its rules, regulations and By-Laws.

More specifically but not by way of limitation, membership in the Club is subject to the
following conditions:

(1) This membership is only to be in effect for such period of time as the Member hereof is
a land owner or tenant of property within the boundaries of the Packanack Lake section of Wayne
Township.

(2) This membership is not transferable.

(3) Any change of Member's class of membership can be effected only by application for
new membership.

(4) Membership can be suspended or terminated in accordance with Article IV of the By-
Laws of the Club.

(5) The obligations of membership shall continue during any period of termination or
suspension but none of the rights or privileges granted hereunder shall continue during said period.

(6) In the event of default in the performance of my obligation of membership in the Club,
the member shall be liable jointly and severally to the Club for all damages suffered and expenses
Incurred by the Club as a result of said default including without limitation reasonable attorneys'
fees and expenses.
