I affirm that I am donating my _____ services to Member/Lessee

I willingly provide these services out of friendship and will not be charging any fee and do not expect and will not accept any monies, fees, reimbursements, compensation, tips or gifts in exchange for these services. I accept all responsibility for my conduct and behavior.

In consideration for participating in the above named service and other valuable consideration, I hereby release, waive, discharge and covenant not to sue Packanack Lake Community Association ("PLCA"), PLCA's Board of Directors, Board of Governors, employees and members from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Member/Lessee or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.

To the best of my knowledge, I can fully participate in this activity. I am fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to voluntarily participate in said activity, and to enter PLCA's premises and engage in such activity knowing that the activity may be hazardous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activity, whether caused by the negligence of the Member/Lessee or otherwise.

I further hereby agree to indemnify and hold harmless PLCA from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activity, whether caused by negligence of the Member/Lessee or otherwise.

It is my express intent that this Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive, shall be deemed as a release, waiver, discharge and covenant not to sue the PLCA, the Board of Governors, the Board of Directors, PLCA employees and PLCA members.

I understand that the PLCA will not be responsible for any medical costs associated with any injury I may sustain.

I also understand that I am responsible for any damage I cause to the facilities.

By signing, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
